Dear Membership,

Our 2020 Annual Membership Meeting will be Friday, March 13, 6 p.m. at Chief David Salmon Tribal Hall.

We will present a report of what's happened in 2019 and what lies ahead for 2020. You'll hear from consumers who use our programs, and meet program staff who will answer your questions.

We have three seats up for re-election with five candidates. Travis Cole, Sharon Hildebrand, Beverly Kokrine, Renee Linton, and Sharon Lee Nicholas are running for the FNA board.



Also on this year's ballot is a proposed change to FNA's Articles of Incorporation. The FNA Articles of Incorporation currently require that all officers of the board terms be one year. The proposed amendment calls for a three-year officer term. This would provide the board executives greater continuity and experience as it would allow officers to fill a position for the duration of their board term. It will also stagger the terms of office so that all of the officers are not replaced in one year. A change to the Articles of Incorporation require two-thirds vote by membership.

Last year you voted to change the membership eligibility requirement. This means that anyone who is 18 years old and is a direct descendant of an Alaska Native or Native American has full voting rights. The new requirement also applies to the FNA board, and FNA pageants.

I encourage you to attend the Annual Membership Meeting to learn about the amazing year 2019 was for us and to vote for your local leadership. We look forward to your attendance because your participation is important and valued.

The FNA Articles of Incorporation currently require that all board officers—president, vice president, secretary and treasurer—terms of office be for one year. The proposed amendment would provide for greater continuity and experience in the officers as it would allow officers to fill a position for the duration of their board term and would stagger the terms of office so that all of the officers are not replaced in one year.

Why are you interested in running for the board?

Every act since then has built upon that foundation that my grandmother laid out for me as a child growing up in the village. As someone who was once on assistance as a young single mother, I first used the FNA Head Start program and was embraced by the program as family. I am interested in giving back to the community and continuing as a board of director. The organization has been successful and I would like to continue to invest my time and resources to see the continued growth of programs.

How to be Counted as an American Indian or Alaska Native

Along with using your village's federally recognized tribal name, it is very important that every American Indian and Alaska Native is counted as American Indian or Alaska Native. One of the most important ways for a person to be counted is by checking the box that says "American Indian or Alaska Native" on the Census form.

Historically, Alaska Natives have been hard to count. As a result, tribal programs—like Head Start—have been underfunded. If you're Alaska Native, you can help our communities and families get their fair share by answering two questions.


The first question asks you to identify your "race?"

If you check the "American Indian or Alaska Native" box, the second question asks you to list your "tribal affiliation."

Alaska Natives can answer the "tribal affiliation" question different ways, however, we encourage you to list your federally recognized tribe.

If you can't remember the name for your tribe, you can write in the name of your village.

You can even write in more than one tribe (or village) if you associate with more than one.







Tritt-Frank awarded UAF honor



The challenges Caroline Tritt-Frank faced while earning her degrees were extreme by any measure. She wore a headlamp to complete her correspondence courses because her family's Arctic Village cabin didn't have

electricity at the time.

Online classes weren't an option, so each of her professors mailed her lessons and assignments. Handing in homework meant either walking a mile each way to the post office or sending a fax one page at a time.

Tritt-Frank, who is a teacher with FNA's Head Start program, received 2020 UAF Distinguished Alumnus Award.

When Tritt-Frank walked across stage at her commencement in 1990, she started a movement. Her husband, daughters and best friend, as well as more than a dozen of her former students, have followed in her footsteps by earning degrees from UAF.

A decade later, Frank-Tritt received her master's degree in education. She became the first woman from Arctic Village to receive a graduate degree.

"I became a teacher because I don't want to lose my language," said Tritt-Frank.
