



Dear Membership,

Our FNA board elections for 2020 and 2021 will be Friday, March 12, 3-7 p.m. at the Chief David Salmon Tribal Hall.

This will be a socially distanced event for casting ballots.

Members may come anytime between 3-7 p.m.

There will be one door to enter and one to exit. Masks and hand sanitizer will be available upon entering. Once registered, you will have an opportunity to cast your ballot. We will provide our membership with a T-shirt, 2020 and 2021 Annual Reports and a meal.

Voters will be entered into a doorprize drawing. Winners will be notified.

The 2020 ballot will have three candidates. Travis Cole (incumbent), Sharon Hildebrand (incumbent), and Renee Linton are running for the FNA board.

Also on the 2020 ballot is a proposed change to FNA's Articles of Incorporation. The FNA Articles of Incorporation currently require that all officers of the board have one year terms. The proposed amendment calls for a three year officer term. This would provide the board executives greater continuity and experience as it would allow officers to fill a position for the duration of their board term.

A change to the Articles of Incorporation require two-thirds vote by membership.

We have five candidates for the three open seats for 2021. They are Terri Cadzow, Tonya Garnett (incumbent), Fatima Lord Tiepelman, Gerald "Jerry" Sam (incumbent), and Charlene Stern (incumbent). The term is for three years.

Your vote is important to FNA, and I encourage you to make it to the Chief David Salmon Tribal Hall o Friday, March 12, between 3-7 p.m. to vote.


All 2020/2021 candidates have met the following requirements:



Shall the Articles of Incorporation of the Fairbanks Native Association be amended to allow the Board of Directors to establish the length of the term of office for the Officers of the Fairbanks Native Association by amendment to the Bylaws as set forth (additions in red underline and deletions in red strike through)?

1) Articles.

a. Amend ARTICLE IX

i. Board Officers: The Officers of the Board shall consist of a President, Vice-president, Secretary and Treasurer, each of whom shall be elected by the Board of Directors for a term established by the Bylaws. ~~(1) year term by the Board of Directors.~~ The qualification, term of office, and method of election or appointment of the Board of Directors shall be set forth in the Bylaws.
